General Information:

¹ Disclosure according to the Maternity Protection Act (article 15 of the MuSchG)

Pregnant students shall inform their university about their pregnancy and the estimated due date as soon as they know that they are pregnant. A nursing student shall inform her university as early as possible about the fact that she is nursing.

A medical certificate like a maternity card or the certificate issued by the midwife needs to be provided as evidence for your pregnancy. The medical certificate shall include the estimated due date.

² Consent for participation in the studies

Pregnant or nursing students are permitted to participate in the studies between 8 pm and 10 pm (article 5, paragraph 2 of the MuSchG, 'Prohibition of night work') as well as on Sundays and public holidays (article 6, paragraph 2 of the MuSchG, 'Prohibition of work on Sundays and public holidays') only if they give their consent to it and if attendance is necessary for training purposes. This decision can be informally revoked at any time in the future by contacting the Student Service Center in written form.

³ Waiver of statutory maternity leave

Female students are allowed to participate in the studies while on maternity leave before or after delivery only if they request it. This decision can be informally revoked at any time in the future (article 3, paragraph 1 and 3 of the MuSchG) by contacting the Student Service Center in written form.
